How has your school's spending increased pupil PE and sport activity levels?	Children at Manor Primary School are now more active than ever before. The school has invested in updated playground equipment and organised regular fitness challenges, encouraging students to participate in a wide range of physical activity.

How has your school's spending increased school sport participation?

Due to the sport funding, children at Manor Primary School have significantly increased their participation in sports. The funding has allowed the school to enhance its sports facilities, acquire modern equipment and offer more sports like table tennis.

How has your school's spending increased pupil participation in extra-curricular activities?

The funding has facilitated the hiring of specialised coaches, such as yoga and gym, and the organisation of regular inter-school competitions, which have further motivated students to get involved. Consequently, the funding has directly contributed to a significant increase in sports participation,

How has your school's spending increased staff training and continued professional development (CPD)?

This financial support has enabled teachers and coaches to attend demonstration lessons, training sessions and workshops, enhancing their skills and knowledge in physical education. The CPD opportunities have equipped the staff with innovative teaching methods and strategies to engage students more effectively in sports.

How has your school's spending increased staff participation in extra-curricular activities and school sports competitions?

We have held events such as staff pupil games and have had children challenge teachers in sporting activities during assemblies. As well as this, staff are now holding school clubs which is enabling the children at Manor to be more active.

How has your school's spending improved swimming attainment?

School have provided top up swimming to year 5 children and have also organised children to go swimming in years 1,3 and 5. We previously had less than 15% of children who were able to swim 25m by year 6 and this years results showed an increase to 20%.

How has your school's spending improved water safety awareness?

The pool's swimming instructors focus on teaching essential skills such as floating, treading water, and safe pool entry and exit practices. As a result, students are becoming more confident and competent in the water, significantly reducing the risk of water-related accidents.
